As a result of the merger in 2012, MPI became the owner of a significant number of legacy fisheries systems that were fragmented and required users to switch systems on a regular basis, to complete day-to-day tasks. The lack of integration between the older systems meant data had to be collected and re-entered several times. MPI used Objective RegWorks (formerly by itree) to deliver a solution that would lead to data collected into a single source of truth.**

MPI was formed in April 2012 after a merger of the Ministry of Agriculture and Forestry (MAF), the Ministry of Fisheries (MFish) and the New Zealand Food Safety Authority (NZFSA). MPI is a significant operational agency with personnel working at sea, at the border, in forests, on farms, in laboratories, along the coastlines, in processing facilities and offshore.

As of 2012, the industries managed within the MPI portfolio represent \$32 billion of New Zealand’s GDP, with strategic plans in place to see this double by 2030.

## A LACK OF INTEGRATION AND INCREASE IN MANUAL PROCESSES

As a result of the merger in 2012, MPI became the owner of a significant number of legacy fisheries systems that were fragmented and required users to switch systems on a regular basis, to complete day-to-day tasks.

The lack of integration between the older systems meant data had to be collected and re-entered several times. It was also difficult to cross-check and analyse data stored in different systems, resulting in manual processing that increased the risk of duplication and human error.

MPI required an off-the-shelf solution that provided staff with a single access point to enter and extract information in a way that aligned with its business processes.

## CONSOLIDATING DATA INTO A SINGLE SOURCE OF TRUTH

MPI implemented Objective RegWorks to deliver a fisheries solution that would lead to consolidation of the right data into a single, secure platform that would streamline enforcement processes and improve the efficiency of human and financial resources.

The solution, named internally as Field Operations Consolidated User System (FOCUS), is designed to deliver enterprise case management and intelligence capabilities that would be integrated across MPI, to unify data from all legacy systems.

Objective RegWorks delivered a solution that encompassed a range of business workflows and associated data, from the recording of a public poacher call, through to investigation and prosecution. Monitoring functions for the health and safety of fisheries officers, who operate in high-risk environments and remote locations, were also configured.

Data migration was a significant component of the project to enable improved intelligence-gathering, analysis and decision-making capabilities. In collaboration with MPI, our team migrated more than 10 years' worth of records from multiple systems.

## A UNIFIED REPOSITORY FOR ALL FISHERIES-RELATED COMPLIANCE DATA

Objective RegWorks has become a single unified repository for all fisheries-related compliance data, including field-based activities, inspections, incidents, permit approvals and enforcement actions such as infringements and prosecution. The system is a one-stop shop for recording, extracting and analysing data required to safeguard fisheries in New Zealand. Objective RegWorks was adopted as a core business system by 240 fisheries officers and in its first month of operation, recorded over 2,400 inspections across New Zealand.
